

SOFTWARE LICENSE AGREEMENT

IMPORTANT NOTICE: THIS SOFTWARE LICENSE AGREEMENT (LICENSE) IS A LEGAL AGREEMENT BETWEEN YOU AND FRAMECAD. READ IT CAREFULLY BEFORE USING THE SOFTWARE OR THE DOCUMENTATION. IT PROVIDES A NON-EXCLUSIVE, LIMITED LICENSE TO USE THE SOFTWARE AND DOCUMENTATION ON THE TERMS OF THE LICENSE AND CONTAINS WARRANTY INFORMATION AND LIABILITY DISCLAIMERS.

BY YOU:

- (A) DOWNLOADING OR INSTALLING THE SOFTWARE AFTER RECEIPT OF THE TERMS OF THIS LICENSE; AND/OR
- (B) ENTERING INTO ANY AGREEMENT WITH FRAMECAD COMPRISING OR INCLUDING THE TERMS OF THIS LICENSE: AND/OR
- (C) OTHERWISE CONFIRMING ACCEPTANCE OF THE TERMS OF THIS LICENSE (USING THE WEBSITE OR OTHERWISE),

YOU ARE CONFIRMING YOUR ACCEPTANCE OF THE SOFTWARE AND THE DOCUMENTATION AND YOU AGREE TO BECOME BOUND BY THE TERMS OF THIS LICENSE.

IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE, WE WILL NOT LICENSE THE SOFTWARE AND DOCUMENTATION TO YOU AND YOU MUST DISCONTINUE THE DOWNLOADING OR INSTALLATION PROCESS.

FRAMECAD MAY FROM TIME TO TIME MODIFY, REPLACE OR AMEND THE TERMS OF THIS LICENSE BY POSTING AN UPDATED COPY OF THE TERMS ON THE WEBSITE OR BY OTHERWISE NOTIFYING YOU OF SUCH MODIFICATION, REPLACEMENT OR AMENDMENT. BY CONTINUING TO USE ANY OR ALL OF THE SOFTWARE; THE DOCUMENTATION; THE LICENSE KEY OR THE WEBSITE AFTER SUCH NOTIFICATION OR PUBLICATION, YOU AGREE TO THE TERMS OF THE LICENSE AS MODIFIED, REPLACED OR AMENDED.

1. DEFINITIONS

"Confidential Information" means any information that is not in the public domain which is obtained by you in the course of or in connection with your use of the Software or the Documentation or any earlier version of the Software or the Documentation, including (to the extent obtained by you) the source code of the Software, the terms of this License, any information contained on the Website, the terms of any associated undertakings made by you in connection with this License and any information about FRAMECAD's business, including all customer lists and databases, whether such information was obtained before or after the date of this License and whether disclosed to you by or on behalf of FRAMECAD, any of its partner organisations, third party service providers, other customers or from any other source. In this definition, the term "FRAMECAD" includes FRAMECAD Limited and all affiliates of FRAMECAD Limited.

"Device" means a single CPU, whether contained in a personal computer, a laptop, a tablet computer, a handheld or other electronic or telecommunication device, a FRAMECAD steel roll-forming machine or item of equipment or any other device, machine or equipment as may be identified by FRAMECAD to you as falling within this definition from time to time.

"Documentation" means the documentation, associated media, printed materials, and online or electronic documentation accompanying or related to the Software.

"FRAMECAD" shall mean FRAMECAD Limited and its successors or assignees, if any.

"Intellectual Property" shall mean and include all intellectual property rights of all kinds including, without limitation, copyrights, patents, trademarks, licenses, systems, designs, trade secrets, inventions, experimental methods and results, technical data, technical information, concepts, ideas, rights in inventions and processes, confidential information, know-how, trade secrets, business names, logos, product get-up, rights in databases and rights of a similar nature anywhere in the world, together with all applications to register any of the foregoing.

"License Fee" means the fee payable in respect of your use of the Software and Documentation for the License Period, as specified by FRAMECAD from time to time including as stated on the Website.

"License Period" means the period for which you are entitled to use the Software and Documentation in accordance with this License, which shall be the length of time (or quantity of production) agreed between you and FRAMECAD when you pay the License Fee in respect of such period and shall commence from the date FRAMECAD sends you a License Key, or otherwise enables you to activate the functionality of the Software for such period. Each such period commences upon receipt by FRAMECAD of the applicable License Fee on the applicable start date (provided that prepayments by you are deemed received at 12.00 am on the applicable start date) and ends at 11.59 pm UTC on the applicable end date.

"License Key" means an electronic password, authorisation code or other enabling mechanism or device (using any software licensing technology) used by FRAMECAD to activate the functionality of the Software .

"Software" means the applicable FRAMECAD Detailer / FRAMECAD Factory / FRAMECAD Factory2/ FRAMECAD Structure/ FRAMECAD Revlink / FRAMECAD Steelwise software program(s), (as such list may be amended from time to time by notice from FRAMECAD to you (including on the Website)).

"User" means an individual person entitled to use have access and use the Software.

"you" means the natural or legal person or entity who downloads the Software , which in many cases will be an organisation represented by one or more individuals, and includes (where the context permits) any natural or legal person whom that organisation permits to use the Software.

"Website" means the website "www.framecad.com" or the website "my.framecad.com", as applicable, or any subsequent URL or URLs used by FRAMECAD from time to time.

2. LICENSE GRANT

The Software and Documentation is licensed on the terms of this License for the License Period only in consideration of the payment by you of a License Fee for that License Period and in consideration of you agreeing to abide by the terms of this License.

Subject to the terms of this License, FRAMECAD grants you the right for the License Period to:

- a. install and use the Software for your internal business purposes only, as follows:
 - for FRAMECAD Factory2: on such number of Devices such that the number of concurrent Devices using such Software at any one time does not exceed the number paid for in advance for the current License Period];
 - for all other Software: on such number of Devices of authorised Users such that the number of concurrent Users using such Software at any one time does not exceed the number of licenses paid for in advance for the current License Period; and;
- use any Documentation in support of the permitted use for the Software set out above.

The License Fee is payable in advance of each License Period and you have no rights to the Software or Documentation under this License for any License Period until FRAMECAD has received the applicable License Fee for such License Period and issued you with a License Key. You may only use the License Key to access and use the Software in accordance with this License for the relevant License Period.

FRAMECAD may communicate with you either via the Website or otherwise prior to the end of the then current License Period to inform you of options to extend this License for a further License Period including the terms (and License Fee) offered by FRAMECAD at that point in time for such further License Period. FRAMECAD shall not, at any time, be under any obligation whatsoever to offer or agree to enter into any further License Period. You may access your license details on the Website or otherwise as determined by FRAMECAD. Such details may include your current licensed Software; the current License Period; the current License Fee and other information as determined by FRAMECAD from time to time.

Upon expiry of the then current License Period without a valid extension of the License for a further License Period, all your rights to use the Software and Documentation immediately cease and this License terminates. If you wish to continue using the Software and Documentation after the expiry of the License Period and FRAMECAD continues to offer licenses to that version of the Software, you may enquire with FRAMECAD about entering into a new software license agreement on whatever terms (and license fee) are offered by FRAMECAD at that point in time as set out on the Website unless other terms are notified to you in writing by FRAMECAD. Such enquiry shall be deemed to be an offer by you which FRAMECAD may accept or reject in its sole discretion and FRAMECAD shall be under no obligation whatsoever to enter into any new software license agreement.





The license granted to you under this License is non-exclusive and non-transferable.

This License applies to updates, supplements, add-on components, or Internet-based services components, of the Software and Documentation that FRAMECAD may provide to you or make available to you after the date you obtain your initial copy of the Software and Documentation, unless they are accompanied by separate terms. FRAMECAD reserves the right to discontinue Internet-based services provided to you or made available to you through the use of the Software

To install and use an upgrade, you must first be licensed for the underlying Software subject to the upgrade. After installing the upgrade, you may no longer use the original Software that formed the basis for your upgrade eligibility, except as part of the upgraded Software.

If FRAMECAD suspects on reasonable grounds that you are or have been using the Software or any other FRAMECAD software without a valid license or other than in accordance with this License or the applicable license terms, it may (in additional to and without limiting any of its other rights under this License) without notice suspend your access to the Software, the Documentation and the License Key until such unauthorised use is resolved to FRAMECAD's satisfaction.

FRAMECAD requires online registration (registered to your company or organisation) on the Website for all software products licensed. You will provide information as requested pertaining to your company or organisation details, registered and physical location, primary contact and contact details, product details, version numbers, authorised Users, and any other relevant information requested and update such information by notification to FRAMECAD if it changes, within 20 days of the change. If you fail to register, if you provide any incorrect or misleading information, or if you fail to notify of any changes to such information within the required period, FRAMECAD may terminate this License at any time by notice to you in writing.

You must supervise and control use of the Software and the Documentation and ensure that the Software and the Documentation is used by your employees in accordance with the terms of this License.

You must include FRAMECAD's copyright notice on all entire and partial copies you make of the Software and the Documentation on any medium or as directed by FRAMECAD.

3. LICENSE RESTRICTIONS

You may not (i) make or distribute copies of the Software or the Documentation; or (ii) use the Software on more concurrent Devices at a time (for FRAMECAD Factory2) or with more concurrent Users at a time (for all other Software), than as purchased by you and as provided in clause 2 of this License .

You may not modify, translate, merge, adapt, vary, reverse engineer, decompile, disassemble or create derivative works based on, the Software or the Documentation or combine the Software or permit the Software to be combined with or incorporated in any other software.

You may not rent, transfer, assign, mortgage, charge, lease, or sublicense any of your rights under this License or to the Software or Documentation to any person or company without the prior written consent of FRAMECAD which, if given, is subject to the transferee's consent to the terms and conditions of this License.

You may not remove any proprietary notices, branding, labels, or marks on the Software, Documentation or License Key.

You may not copy, interfere with, modify, disassemble or reverse engineer the License Key and must not attempt to work around, re-create or circumvent the License Key or any requirement in the Software for the License Key. If you lose the License Key or the License Key is damaged or ceases to operate, please contact FRAMECAD immediately to request a replacement.

You must ensure that only authorised individuals within your organisation have access to and use the Software, the Documentation and the License Key and that all such individuals at all times comply with the terms of this License.

4. AUDIT

You agree that both during the term of this License and for the period of 3 years after its termination or expiry FRAMECAD or its authorised representatives may at any time during normal business hours on at least one business day's notice inspect and have access to any premises and computer equipment or other Devices located there at which the Software or Documentation is being kept or used and any records kept in relation to your use of the Software or this License, to ensure you are complying and have always complied with the terms of this License and/or are not using any other FRAMECAD software without a valid license or in breach of its applicable license terms. In the event that any such audit reveals any non-compliance with the terms of this License or other applicable license terms or reveals any unlicensed use of any FRAMECAD software, you shall bear all of FRAMECAD's costs in carrying out such audit in addition to any other remedies FRAMECAD may have in respect of the non-compliance or unauthorised use.

5. INTELLECTUAL PROPERTY AND OWNERSHIP

You acknowledge that rights in the Software and the Documentation are licensed (not sold) to you. This License gives you a limited license to use the Software for the License Period. FRAMECAD retains all right, title and interest, including all copyright and other Intellectual Property rights, in and to, the Software, the Documentation, and all copies thereof. FRAMECAD retains all right, title and interest, including all copyright and other intellectual property rights, in and to the License Key. All rights not specifically granted in this License, including to New Zealand and International Copyright, are reserved by FRAMECAD and its suppliers. Unauthorised copying of the Software or the Documentation or failure by you to comply with any of the terms of this License in full will result in automatic termination of this license and prosecution to the maximum extent allowed under law.

You acknowledge that you have no right to have access to the Software in source code form or in unlocked coding or with comments.

All Intellectual Property in the Software or Documentation arising as a result of the use of the Software or the Documentation by you or any other person as anticipated under this License or otherwise will be, from the point of creation, the sole property of FRAMECAD. You hereby assign to FRAMECAD from the point of creation all rights in and to all such Intellectual Property and agree to undertake all acts and execute all documents necessary to effect such transfer.

This License does not grant you any rights to trademarks, service marks or trade names of FRAMECAD, including, without limitation, the FRAMECAD logo or any other intellectual property of FRAMECAD. All rights in these trade marks, service marks and trade names or other intellectual property shall remain owned exclusively by FRAMECAD.

The integrity of the Software may be protected by technical protection measures (TPM) so that the intellectual property rights, including copyright, in the Software are not misappropriated. You must not attempt in any way to remove or circumvent any such TPM, nor apply or manufacture for sale or hire, import, distribute, sell or let for hire, offer or expose for sale or hire, advertise for sale or hire or have in your possession for private or commercial purposes any means the sole intended purpose of which is to facilitate the unauthorised removal or circumvention of such TPM. In addition, the Software may have embedded in it certain licensed software security elements (LSSE) owned by a third party and licensed to FRAMECAD. You agree that the LSSE is provided on a licensed basis only and that ownership of the LSSE and associated code and components lies with FRAMECAD or its licensors and not with you. You agree that the LSSE is confidential and proprietary to FRAMECAD or its licensors. You will not make any unauthorised use of the LSSE or attempt to determine its source code. You accept that FRAMECAD and its licensors disclaim any and all warranties and other liabilities with regard to the LSSE. The LSSE supports the detection of unauthorised use or copying of the Software and it may report such unauthorised use or copying to FRAMECAD and may report back specific User information, including, without limitation, User name or email address (as opposed to a domain name), IP address, and geographic location and acceptance of this License by you (including as provided on the first page above) is an affirmative acknowledgement and acceptance of the foregoing by you.

6. WARRANTY AND DISCLAIMER

THE SOFTWARE AND DOCUMENTATION IS SUPPLIED TO YOU "AS IS" AND EXCEPT FOR ANY WARRANTIES EXPRESSLY STATED IN THIS LICENSE OR EXPRESSLY REQUIRED BY APPLICABLE LAW, FRAMECAD MAKES, AND YOU RECEIVE, NO WARRANTIES, EXPRESS, IMPLIED, STATUTORY OR IN ANY COMMUNICATION WITH YOU, AND FRAMECAD SPECIFICALLY DISCLAIMS ANY IMPLIED WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR OF NON-INFRINGEMENT OF ANY THIRD PARTY'S INTELLECTUAL PROPERTY RIGHTS. FRAMECAD DOES NOT WARRANT THAT THE OPERATION OF THE SOFTWARE WILL BE UNINTERRUPTED OR ERROR FREE.

SOFTWARE AND DOCUMENTATION PROVIDED IN LANGUAGES OTHER THAN ENGLISH ARE TRANSLATED FROM ENGLISH USING COMMERCIALLY REASONABLE EFFORTS TO ACHIEVE ACCURACY, HOWEVER ACCURACY IS EXPLICITLY NOT GUARANTEED.





Some countries do not allow the exclusion of implied warranties so the above exclusions may not apply to you. This warranty gives you specific legal rights. You may also have other rights, which vary, from state to state and country to country.

7. BASIS OF BARGAIN

You warrant that you have reviewed the minimum system requirements, if any, specified by FRAMECAD from time to time in respect of Devices which can run the Software, or as provided in this License, and are satisfied that all Devices on which you intend to run the Software comply with such specifications.

8. LIABILITY AND INDEMNITY

You acknowledge that the Software and the Documentation have not been developed to meet your individual requirements, and that it is therefore your responsibility to ensure that the facilities and functions of the Software as described in the Documentation meet your requirements.

FRAMECAD only supplies the Software and Documentation for internal use by your business, and you agree not to use the Software or Documentation for any re-sale purposes.

To the maximum extent permitted by applicable law, in no event shall FRAMECAD or its suppliers be liable, whether in contract, tort (including negligence), or otherwise, for any:

- a. loss of profits, sales, business or revenue, loss of Confidential Information or other information, business interruption, loss of anticipated savings, loss of opportunity, loss or corruption of data or information, loss of goodwill or reputation;
- b. any special, incidental, indirect, or consequential loss; or
- c. for any other pecuniary or other loss whatsoever, including arising out of or in any way related to the use of or inability to use the Software, the Documentation and/or the License Key, Software locked through unpaid License Fees, Software viruses, the provision of or failure to provide support services, or otherwise under or in connection with any provision of this License, even in the event of the fault, tort (including negligence), strict liability, breach of contract or breach of warranty of FRAMECAD or any supplier, and even if FRAMECAD or any supplier has been advised of the possibility of such damages.

Notwithstanding the above exclusions, in the event that FRAMECAD is liable to you for any reason whatsoever, (including, without limitation, in respect of any damages referenced above and all direct or general damages), the entire liability of FRAMECAD and any of its suppliers under any provision of this License and your exclusive remedy for all of the foregoing shall be limited to the amount of the License Fee actually paid by you in respect of the most recent License Period. The foregoing limitations, exclusions and disclaimers shall apply to the maximum extent permitted by applicable law, even if any remedy fails its essential purpose.

Nothing in this clause 7 excludes FRAMECAD's liability for death or personal injury or any other liability that cannot be excluded or limited by New Zealand law.

You warrant that you are acquiring the rights to use the Software and the Documentation on the terms of this License for a business purpose and that as a result the New Zealand Consumer Guarantees Act 1993 and any equivalent laws or other consumer protection laws which may be applicable do not apply. If you wish to use the Software and the Documentation for personal (i.e. non-business) use, please contact us and we may be able to agree an alternative license with you.

You indemnify FRAMECAD in respect of all losses (including any license fees which FRAMECAD would otherwise have been entitled to), claims, proceedings, demands, costs and expenses (including actual legal costs incurred) arising out of (i) your use of the Software and the Documentation other than in accordance with this License and any instructions or directions of FRAMECAD; (ii) your use of any other FRAMECAD software other than in accordance with its license terms; (iii) any unauthorised use of the Software or Documentation by any third party which occurs directly or indirectly as a result of your failure to comply with this License; and (iv) the materials you design or produce through use of the Software and the Documentation, including any failure to comply with any applicable building codes; (v) any failure by you to comply with any applicable law or to obtain any necessary approval or consent in respect of your use of the Software or any design or materials produced as a result of your use of the Software.

Clauses 6 and 7 set forth above are fundamental elements of the basis of the agreement between FRAMECAD and you as set out in this License. FRAMECAD would not be able to provide the Software to you for only the agreed License Fee without such limitations. These clauses enure to the benefit of FRAMECAD's licensors.

9. ASSIGNMENT

FRAMECAD may at any time assign, delegate, sublicense, or transfer in whole or in part its rights or obligations under this License to other entities within the FRAMECAD group or to any third party. You may not at any time assign, delegate, sublicense, or transfer in whole or in part your rights or obligations under this License without the prior written consent of FRAMECAD.

10. CONFIDENTIAL INFORMATION

FRAMECAD retains all intellectual property rights, title and interest in the Confidential Information. You must use the Confidential Information solely for the purpose of installing and using the Software for your internal business purposes.

You acknowledge that the Confidential Information is provided on terms of strict confidentiality and agree to:

- a. establish and maintain proper and effective security measures to safeguard the Confidential Information at all times from unauthorised access or use;
- b. keep the Confidential Information under your control;
- c. immediately notify FRAMECAD of any suspected or actual unauthorised use, copying or disclosure of the Confidential Information;
- d. provide all assistance that is reasonably requested by FRAMECAD in relation to any proceedings that FRAMECAD may take against any person for unauthorised use, copying or disclosure of the Confidential Information; and
- e. if requested by FRAMECAD, ensure that each of your personnel who may have access to Confidential Information enters into a binding confidentiality agreement directly with FRAMECAD in a form reasonably required by FRAMECAD. FRAMECAD may withhold activation of the Software or any License Keys until all requested undertakings have been received.

The obligations under this clause continue to apply after termination of this License or expiry of the License Period. You will on request return the Confidential Information to FRAMECAD or destroy it and, if requested, certify to FRAMECAD in writing that all copies of the Confidential Information have been deleted and / or returned, as required by FRAMECAD.

11. TERMINATION

You may voluntarily terminate this License at any time after payment in full of all amounts owing by you to FRAMECAD under this License. Termination of the License for any reason does not entitle Licensee to any refund for remaining license period.

FRAMECAD may terminate this License immediately upon written notice to you if you fail to comply with this License or any other agreement between you and FRAMECAD or any related company (as defined in the Companies Act 1993) of FRAMECAD.

In the event of termination of this License or expiry of the License Period as provided in this clause 11 or elsewhere in this License, all your rights in respect of the Software and Documentation will immediately cease and you must immediately cease all activities authorised by this License. You must, within 30 days of such termination, delete or remove any installed Software, unless you have entered into a new software license agreement, paid the applicable license fee under that new software license agreement and FRAMECAD has notified you that you may continue to use the same Software, Documentation and/or License Key. You will on request certify to FRAMECAD in writing that all copies have been deleted as required by this clause.

Termination of this License shall be without prejudice of any rights accrued prior to termination and all provisions of this License intended to survive termination shall continue in full force and effect.





12. BASIC SUPPORT

Payment of the License Fee as provided in clause 2 entitles you to receive Basic Support during the applicable License Period only.

Basic Support is as described below in this clause 12, as may be modified by FRAMECAD by notice to you from time to time, including as may be set out on the Website from time to time.

Basic Support will be available to Users to the extent that this is consistent with the license rights for the applicable Software granted as provided in clause 2 (i.e. by reference to numbers of Users and numbers of Devices, as applicable depending on the Software). FRAMECAD reserves the right to limit the number of persons provided Basic Support to equal the number of purchased subscription licenses (i.e. if you have a current right for 5 Users, only 5 Users can log support tickets for Basic Support).

Basic Support comprises:

- a the provision by FRAMECAD of updates, patches and fixes in respect of the Software as part of a general roll-out by FRAMECAD from time to time or otherwise as determined by FRAMECAD; and
- b the facility for you and your Users to log defects in respect of Software to FRAMECAD using the Website or in the manner determined by FRAMECAD from time to time and to receive a response to such defect log.

Basic Support does not include training or instruction in use of the Software by you or your Users.

Basic Support will only be provided for the most recent version of the Software. You and your Users may be required by FRAMECAD to update the Software licensed to you to the most recent version in order to have the right to receive Basic Support (or any other support by FRAMECAD).

Basic Support is subject to a "fair use" limitation. FRAMECAD reserves the right by notice to you to limit further access by you and your Users to Basic Support if we determine, acting reasonably, that the use of the Basic Support over the License Period by you and/or your Users has exceeded a reasonable volume of use as compared to industry norms or as compared to the use by other licensees of our Software.

You must inform FRAMECAD as soon as reasonably practicable, and by giving reasonable details and information to FRAMECAD, if you or a User becomes aware of any technical issue or defect in the Software.

13. CONFIGURATION DATA AND USE OF INFORMATION

You are solely responsible for developing, inputting, amending, maintaining and regularly backing up the configuration settings, data files and scripts applicable to your use of the Software (Configuration Data). FRAMECAD does not guarantee that upgrades or updates to the Software will be compatible with your Configuration Data and you may need to revise, re-enter and/or update the Configuration Data from time to time. Both the initial development and entry of such Configuration Data and all revisions, re-entry or updating to the Configuration Data from time to time (including where required as a result of an upgrade or update) shall be solely at your own cost.

You agree and acknowledge that FRAMECAD and/or its affiliates may during the License Period and subsequently collect, log, store, use and or disseminate technical and usage information gathered as part of any product support services provided to you, if any, related to the Software and Documentation. FRAMECAD may use this information to improve its products or to provide customised services or technologies to you.

Without limitation to the previous paragraph in this clause 13, FRAMECAD and/or its affiliates may during the License Period and subsequently, through the Software or otherwise, collect, log, store, use and/or disseminate any one or more of the following categories of information about you and your activities (each, and together, **User Information**): Software functions used, activity time and duration, operating system in use and system type in use (32/64 bit), Software and Software version in use, Software serial and/or License Key and/or other licensing identity details (i.e. associated software and hardware keys), MAC address, whether a trial or full version is being used by you, Software expiry date and status, your internet protocol address (which may allow FRAMECAD and/or its affiliates to determine computer location) and crash report data.

You consent to the storage, use and dissemination of the User Information by FRAMECAD in the manner anticipated in this License or as may be required by FRAMECAD from time to time, including as provided in our Privacy Policy in force from time to time as set out on the Website. The rights of FRAMECAD under this License and your obligations under this License are in addition to any rights of FRAMECAD and any obligations of you under the MyFRAMECAD Terms and Conditions, or other FRAMECAD cloud services terms and conditions, or as otherwise agreed between FRAMECAD and you from time to time.

15. EVENTS OUTSIDE OUR CONTROL
